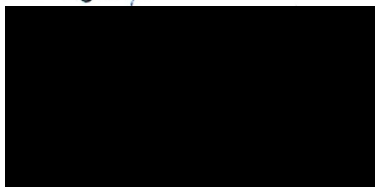

Proposal for New Bus Service to Whanganui Airport

Executive Summary:

We propose the establishment of a new bus service to cater to the growing needs of travellers to and from Whanganui Airport. With approximately 150 people utilizing the airport facilities each day, including a significant number of students from NZICPA, there exists a clear demand for reliable transportation. Our proposed service aims to accommodate this demand efficiently, providing convenient one-hour intervals between buses while also extending its reach to serve the wider Whanganui community.

Introduction:

Whanganui Airport serves as a crucial gateway for both travellers and students, with the New Zealand International Commercial Pilot Academy (NZICPA) contributing substantially to the passenger traffic. As Air Chathams increases its aircraft size and seating capacity, the need for reliable transportation becomes ever more pressing. Our proposed bus service seeks to address this need comprehensively, ensuring seamless connectivity between the airport and surrounding areas.

Key Features of the Proposed Service:

1. Frequency and Timing:

- The bus service would hopefully operate at half-hour or one-hour intervals, ensuring passengers have convenient options throughout the day.
- This frequency is designed to accommodate the diverse schedules of both regular travellers and students attending NZICPA.

2. Target Audience:

- With approximately 132 students expected at NZICPA, we anticipate a significant portion of our daily ridership to comprise students traveling to and from the academy.
- Additionally, the service caters to other travellers, airport staff, and residents of Whanganui requiring transportation to the airport.

3. Route Coverage:

- Our service will not only connect the airport but also extend its reach to cover key areas within Whanganui i.e. a bus service for Putiki which it currently does not have.

- By serving the broader community, the aim is to enhance accessibility to the airport for residents and visitors alike.

4. Adaptability to Growth:

- As Air Chathams expands its operations, hopefully the service is prepared to accommodate the anticipated increase in passenger traffic.
