There is no public transport they can access, other than subsidised mobility taxi's, which is inhibitively expensive if wanting to travel out of town. Intercity buses are out of the question as they are not wheelchair accessible, and expensive for those that can board. Plus bookings a head of time are required. This is an appalling situation and must be rectified.

The Government, in association with Horizons Regional Council and Wellington Regional Council are purchasing Hitachi hybrid rail units, for use between Wellington and Palmerston North (and Wellington to Masterton,) but these need to be extended further a field, to cater for those in other small towns.

Public transport in this region, and many other parts of New Zealand for that matter, has never been seen as anything other than a nice-to-have, as of no importance in the over all scheme of things. Non motorists have been neglected in favour of the private motor car for far too long. Not just are the disabled, the young and the elderly being given a disservice, but so to is the environment. Please make the neccessary and required changes to implement good public transport throughout this region, the health, safety, and general wellbeing of many people are relying on them.

## Makerua Drainage Scheme Liaison Committee Submission LTP 2024.

### Rates.

Rate increases in the order of 25 – 30% are outrageous and completely unaffordable. In some cases increases will be considerably greater. Two examples are listed below, these are actual examples, one an average sized cropping farm and one an average sized dairy farm. Both are family farms, not large corporate entities.

\$27,253	\$32,745
\$ 8,700 proposed increase	\$10,238 proposed increase
\$35,953 31.92%	\$42,983 31.26%

This is out of line with the general economy and coming at a time when all forms of agriculture returns are diminishing. The compounding effect in future years would be totally unsustainable.

#### **General Rate Contribution.**

The Liaison Committee is totally against the proposed reduction in contribution from the general rate to the Drainage Scheme from 20 to 10%. The Horizons regional economy benefits greatly from the contribution made by the ratepayers of the Drainage Scheme. Without the Drainage Scheme economic contribution made by the farming community would be vastly reduced.

Status Quo should remain. The proposed reduction has come with very little warning and at a time of exponential increases in input costs. This is unacceptable.

#### Specific activities.

We need an actual works programme, what work will take place and when, a better working relationship ("more contact ") between the Scheme Engineer and the Liaison Committee. The works programme needs to be available and discussed at Liaison Committee level, so it can be disseminated amongst the ratepayers. This will lead to a better understanding of the level of service ratepayers can expect – currently there is a vacuum. Drain maintenance is the key to the Schemes success, it has been noted over the last several years that maintenance has been reducing while rates continue to increase. Often a reactionary rather than a proactive approach.

As ratepayers confronted by this dramatic increase, they need to know what services they can expect, and where their money is being spent.

#### Finances

Since Covid and the lack of meetings there has been an overall lack of clarity for the Scheme finances and therefore accountability.

To propose 25 – 30% increases without a clear ratepayer understanding of the issues is insupportable.

We wish to speak to this submission.

- Horizons Regional council to support horse riders from both sides of the Manawatu gorge, and nationally, to ensure the new Expressway replacement of the Manawatu Gorge has full Cycling, Walking and Bridleway (CWB) capacity. Accept nothing less than the multiuse access that has been afforded in the Kapiti District.
- PNC and Horizons councils to work with local horse riders on local planning and strategy. For horse riders to be stakeholders in all strategy review and planning and to be included in any shared path committees or advisory groups that report back to council.
- Horizons regional council and Palmerston North City Council to include horse styles, hitching rails and or horse pens at CWB destinations and public toilets and on CWB tracks.

- Ongoing track maintenance of grassed path edges on CWB tracks i.e. cutting back foliage and overgrowth so horse can use the soft edge
- Review of all paper roads with a view to open them for Cycleway, Walkway and Bridleway use

- Use equestrian friendly language in all radio and newspaper communication for on and off road, inclusive language when discussing trails and open spaces. Safety messaging regarding driving past horse and carriage riders in road safety campaigns.
- Work with Palmerston North City council on linking to their CWB master plan that has links to the west coast down to Horowhenua in Manakau both on the Expressway track and in the hills.
- Promotion and support of Bridleways within and outside of the district, plan links with Kapiti Cycleway Walkway Bridleway network both on and off the Expressway, and plan links to the Manawatu trails planed from Palmerston North to Himitangi rail trail. Engage with the rail trail trust to see how links can be established for all users from the end of the O2NL shared path north to Palmerston North and then over to the Wairarapa on the new Manawatu gorge replacement road, Te Ahu a Turanga.
- Promote and encourage the establishment and/or extension of equestrian related business
- Undertake economic impact research into the financial contribution to the district and region from the horse-riding community both recreational and racing (conservative estimate for Manawatu \$65 million annually excluding land purchase and rates)
- Undertake economic modelling and strategic planning of the potential for tourism from Equestrian tourists (as well as other multiuse pathway users) if CWB pathways are developed both within, and linking outside of the district and region. There is potential for a CWB path to extend from the Hutt Valley on Transmission gully, through Kapiti, into Horowhenua, north to Palmerston North and then over the hills to Woodville and beyond.
- Equestrian community and potential to be included in Economic development plans and strategy.
- Horses to be part of disaster response and recovery plan PNCC and Horizons Regional council. The horse-riding community can be very useful in times of disaster like seen in Cyclone Gabrielle for transport and connecting communities.

- District and regional float parking plan that accommodates float parking at entry points to bridleways and shared pathways. Larger parking areas are also needed for cars with cycles on them that need more room.
- Explore opportunities for recreational horse grazing on public land to ensure future of riding in the district (Palmerston North, Manawatu, Horizons and DOC) Maintain adequate open space with a view to accommodate equestrian sport and grazing.
- Review PNCC's Parks and reserves policy which excludes horses from use of parks and reserves and revisit this position in light of the very successful multiuse user policy in Kapiti. For Horizons to similarly work with equestrians on any policy review needed to ensure there is not exclusion of horse riders as a recreational group, which is mostly female recreational pursuit.
- PNCC, Mnawatu and Horizons to support Equestrians (horse riders and carriage drivers) from across the district and nationally on the campaign to have the shared path on the O2NL include Cyclists, Walkers and Horse riders (CWB) as has been the case in the Kapiti district, accept nothing less from NZTA but the multiuse access that has been afforded in the Kapiti District.



Long Text The Feilding - Palmerston North Bus Service's route through Bunnythorpe was changed (sometime after 2010 I think so that it no longer goes over the rail at the crossing in Bunnythorpe with the Barrier Arms, but continues through Bunnythorpe, turns right at Stoney Creek Road, right at Clevely Line and over the rail at Clevely Line where there are no barrier arms. Those in Bunnythorpe were unaware this change was happening and since then there have been two bus crashes - one fatal at the Clevely Line rail crossing a few years back and another recently at the Stoney Creek Road/Clevely Line intersection (not sure if anyone was injured but emergency services attended and the damaged bus required transportation. This has always been known to Bunnythorpe residents as a notoriously dangerous corner. Not sure what the reason was for this route to be used as there are no bus-stops along it. The bus could continue to use the bus-stops on Campbell Road in Bunnythorpe but go around the Dixons Line, Baring Street, Dutton Street block and then use the crossing in Bunnythorpe that has Barrier Arms and to avoid the Stoney Creek Road/Clevely Line intersection. The bus stops could also be changed to Baring Street, a less busy thoroughfare for the bus to navigate and for passengers to embark/disembark.

The seven groups resident in the Horizons region have needs for equipment, training and operational expenses over and above what the national Land Search and Rescue organisation can provide. The additional support and security through a Horizons Regional Council contribution will in return support the work of local volunteers in their communities and strengthen the safety net these community-based volunteers provide. The funding will be used to support the local group and local members at a local community level.

It is costly to safely equip and train a Land Search and Rescue volunteer ready for field operations. Additionally Land Search and Rescue volunteers support the lead agency (Police or Rescue Coordination Centre) with an incident management capability. This includes a range of costly technology and equipment (i.e. computers, scanners, printers, data projectors, communication equipment, mapping software etc....).





Support from Ruapehu Alpine Rescue Organisation for the Land Search and Rescue NZ submission to the Horizons Regional Council Long-Term Plan 2024-34. By Horizons providing financial support to the seven Land Search and Rescue groups in the Horizons region. With the purpose for assistance with equipment, training and other operational expenses over and above what the national organisation can currently provide.

Ruapehu Alpine Rescue Organisation (RARO) responds to people in need around the Ruapehu region. This is a key place for people of the Manawatu/Whanganui region with many partaking in the recreational opportunities in the area. We train and equip our volunteer members to ensure that when people are in need in steep or remote terrain in the area we can respond to them. This has been done consistently since RARO was formed in the mid 90's. Many lives have been saved in this time and even this year we have had people say that without the support of the Organisation there would have been a dramatically worse outcome from their experience.

RARO is one of seven Land Search and Rescue groups resident in the Horizons region. There is a need for equipment, training and operational expenses over and above what the national Land Search and Rescue organisation can provide. The additional support and security through a Horizons Regional Council contribution will in return support the work of local volunteers in their communities and strengthen the safety net these community-based volunteers provide. The funding will be used to support the local group and local members at a local community level.

It is costly to safely equip and train a Land Search and Rescue volunteer ready for field operations. Additionally Land Search and Rescue volunteers support the lead agency (Police or Rescue Coordination Centre) with an incident management capability. This includes a range of costly technology and equipment (i.e. computers, scanners, printers, data projectors, communication equipment, mapping software etc....).

There is an acknowledgement that Horizons Regional Council faces many challenges in a post Covid environment. A modest contribution from ratepayers will support the efforts of community-based emergency services volunteers, it will support the provision of a safety net and continue to generate positive and tangible benefits for our communities, residents and visitors.
